The keyboarding speed for admission requirement was reduced to 40. A new course was added to the graduation requirements. The course is NUCL 100, and it will provide an overview of the program to students.

The grading of courses was clarified. Language was added for reserved seats for Indigenous or AUD pathway students. The re-entry and supplemental assessment language was updated. The language throughout the policy was made more accepting.
